### Enrollment Agreement for Lollipop Tree Nursery School, West Hartford, CT

Welcome to Lollipop Tree Nursery School. We look forward to a happy relationship with each family. Lollipop Tree will operate as a private facility. The school will admit all children regardless of race, color, nationality or religious background. This agreement and the policies included shall govern the relationship between the School, the children and you, as a parent.

#### ARRIVAL AND DEPARTURE PROCEDURES

1. Lollipop Tree Nursery School is open from 7:30 am to 5:30 pm, Monday thru Friday. Children may not enter the center before 7:30 am or be here later than 5:30 pm, as our liability insurance will not cover them. As a general guideline, Lollipop Tree follows the West Hartford Public School System for closings, delayed openings, school breaks and holidays. The school is closed for certain religious holidays as well. Please refer to the calendar enclosed in your application packet.
2. Lollipop Tree Nursery School will be open whenever possible on a regularly scheduled day during normal hours. Lollipop Tree Nursery School will follow the West Hartford School System for closing and late openings. It is the parents' responsibility to listen to the radio or watch on TV to see if West Hartford schools are closed or delayed. If we open at 9:00 am, we will try not to close before 1:00 pm due to weather conditions. Additionally, we make all efforts to stay open until 5:30 pm. Should it become necessary to close early (after 1:00 pm) due to severe weather or any other unsafe condition it will be the parent's responsibility to arrange for the child to be picked up early. In any event, there will be no tuition credit for any time the program is closed.
3. To ensure children are always safe and supervised, parents are expected to accompany children into Lollipop Tree and supervise children after signing them out of the classroom at the end of the day. Parents are also expected to hold their child's hand in the parking lot for safety reasons.
4. Parents or any adult bringing the child to a classroom is required to sign the child / children in and out daily with the time of day, time being picked up and the person who will be picking up the child.
5. Children will be released only to a parent or legal guardian and to persons whose names are listed on the Authorization and Consent form. Parents should advise the Director and classroom teachers in advance, in writing, if a person not listed on the original form is to pick up the child.

Photo identification will be requested of these authorized persons when picking up the child.
